



PRIVACY POLICY

This website is administered by and is a property of the Finnish Business Group in Ukraine.

Administration of fbg-ua.org (hereafter the "Site") shall be obliged to save your confidentiality on the Internet. We place great store on data privacy provided by you. Our Privacy Policy founded on demands of [General Data Protection Regulations of the European Union \(GDPR\)](#) and the Law of Ukraine "On Personal Data Protection".

We gather personal data with the view to: account of FBG-Members, establish contacts with the visitors to the Site, update e-mails, provide information requested by the user, provide services and carry out events associated with the direction of activities of the Finnish Business Group and the Site, as well as for actions here below.

Gathering and Use of Personal Data

We gather and use your personal data only if you gave voluntary consent through filling in the corresponding form containing the personal data.

We receive and collect personal data when you use Site's functions and specifically when you:

- send the application for membership through the site;
- send a request through the website;
- register for events organized by the Finnish Business Group in Ukraine.

Please note that the use of the Site as such does not give rise to the processing (particularly collection) of visitor's personal data. Upon selecting the contact form or application for membership offered by the website, you will be clearly pointed out to the fields required to be filled in, where you should put down the minimum data necessary to receive the requested information.

If you agreed, you allow us to gather and use the following data: first name and last name, e-mail and telephone number. Gathering and use of your data shall be conducted under the effective laws of the European Union and Ukraine.

Data storing, modification and deletion

The user who submitted his/her personal data to the Site shall have the right to modify and delete them, as well as to withdraw his/her consent for their use. The period during which your personal data will be stored is 24 months. Upon completion of using your data, admins of the site delete them. For access to your personal data, you can contact the Site Administration by email: finnishbusinessgroup@gmail.com We can render your personal data to the third party only with your voluntary consent, should they be transferred, and then we can't perform data modification in other organizations that are not related to us.

Technical Data Usage when Visiting the Site

Data base keeps records on your IP address, time session, browser settings, operational system, as well as other technical information required for correct displaying of the Site content while your session at fbg-ua.org. It is impossible to identify the user's personality on these data.

Cookies Usage

We use Cookies to display content of the Site and for ease use of fbg-ua.org. These are small files kept on your equipment. They help to the Site to remember the information about you, for example, what language do you use while session and what pages have you opened. The information will be helpful while the following session. By means of Cookies Site session is more useful. Please, [read here](#)



if you want to find out details of Cookies. You can set acceptance or blocking of Cookies in your browser without assistance. Site efficiency can be reduced because of failure to accept Cookies.

Use of Personal Data by the Other Services

The Site uses third-parties Internet Services performing information collection independent of us, such as Google Analytics, Google AdSense, Facebook.com. Data collected by them are provided by other services inside the organizations. They may use data for advertising personalization of own ad network. You can read user agreements of the organizations on their Sites. As well, you can withdraw from personal data collection by them. For example, Google Analytics [is here](#). We don't render personal data to other organizations and services unspecified in Privacy Policy. An exception is transfer of information under legal requirements of state agencies being authorized to perform such actions

Privacy Policy Modification
